Invest in Children Grants Proposal Guidelines 2007



Mission and Goals

CHILDREN FIRST was established by Paul and Lilly Merga in 2005 to extend early childhood development opportunities to children from low-income families in Orange County. Like national and local child development experts, they strongly believe that good development experiences help expand the abilities of children to succeed in life. In addition, CHILDREN FIRST believes that retirees have the accumulated wisdom, experience, skills, and desire to lend a real helping hand to early childhood development providers. CHILDREN FIRST is focused on mobilizing skilled retirees to assist local providers to offer educational opportunities for children ages 0-5.

Invest in Children Fund

CHILDREN FIRST encourages retirees and community leaders to donate to the Invest in Children Fund administered by the Orange County Community Foundation. The fund generates money from the community to support innovative and critically needed early childhood development programs serving low-income children in Orange County. The “return on investment” to each retiree is expanded educational and quality-of-life opportunity for needy children. The results of the investment lead to a healthier and stronger community.

Eligibility Requirements

Organizations and/or programs eligible to apply must:

- Be located in Orange County.
- Serve low-income children ages 0-5 and/or families with children. At least 50% of participants must be considered low-income.
- Have 501 (c) (3) Status.

Funding Opportunities

The Fund provides grants of up to \$25,000 per year, for a maximum of three years, to support innovative early childhood development programs *servicing children ages 0-5 from low-income families in Orange County*. Receipt of an initial grant for one year does not guarantee receipt of further grants. All grants depend on the availability of funds. Second and third year grants depend upon a review of program performance and the consistency of the application for continued funding with grant criteria.

Grants can be used for strategic planning, enrichment of present programs and initiation of new programs in the following three areas of interest:

1. Educational Development: Innovative programs that increase the language, reasoning, problem-solving, motor, and communication skills of low-income children in early childhood development centers (ECDC) or programs.
2. Health Development: Health screenings, preventive care, and nutrition counseling that occur in partnership with ECDC or programs.

3. **Parent Involvement:** Parent guidance and involvement programs. These programs should expand opportunities for parents of children ages 0-5 and in collaboration with ECDC or non-profit organizations that provides services to low-income children.

In order to leverage grants and current initiatives, CHILDREN FIRST will grant preferences to ECDC that need and agree to utilize skilled retirees (e.g. doctors, nurses, teachers, etc.) recruited by CHILDREN FIRST.

Requests for the following will be denied

The Invest in Children Fund will not offer financial assistance and is not limited to the following items:

- Individual scholarships, fellowships and grants
- Political campaigns or lobbying
- Travel Expenses
- Deficit reduction
- Programs that do not support the goals or mission of CHILDREN FIRST.

Format of Proposal

The proposal must be formatted based on the following criteria:

- Eight (8) page limit. Include page numbers.
- 12 point font.
- Double spaced.
- One inch margins all around.
- 8 1/2 x 11 inch paper.

Application Submittal

Applications must be delivered to CHILDREN FIRST no later than Friday October 26, 2007 by 5:00 p.m. Postmark and or proof of transmittal alone will not be considered timely. All applications will receive a receipt.

NARRATIVE

I. Program Summary

Briefly describe the program in 1-2 sentences.

II. Organization: History and Capacity

Provide a brief description of the history of your organization include mission statement, services provided, geographic location and population served if different than proposal. State staff qualifications and explain why your organization can complete the proposed program.

III. Program Description and Need

Describe the problem, goals, and strategies your proposed program will address and utilize. The proposal should provide information on how you plan to solve the issue you identified and how it relates to improving the lives of young children in Orange County. This section should discuss how your program or project is a fit with the Foundation's areas of interest and if it is in the areas of preference.
